The Stock Option vests over four years as follows: 25% of the underlying securities vested on July 1, 2010, and the remaining underlying securities vest each month thereafter, subject to the Reporting Person's continuous service to the Issuer through each such vesting date.
- The shares reported in column 9 of Table II represents the aggregate number of shares subject to Stock Options held of the same class, exercise price and expiration date, which includes two grants previously reported on separate line items in the Form 3 filed on January 24, 2012.
